## CALL FOR ENTRIES

Regional Juried Art Exhibition: Open ONLY to Washington DC, Maryland, and Virginia Artists

Exhibition Dates: January 10-May 4, 2024 Dates for Submissions: Friday, October 13-Tuesday, November 21, 2023

**ELIGIBILITY:** Open <u>only</u> to artists residing in the District of Columbia, Maryland, and Virginia. Original hanging work, in any medium, will be considered.

**ENTRY FEE:** \$40 for up to 5 pieces; \$10 for each additional piece. Payment through PayPal (which accepts all major credit cards).

**GUIDELINES:** Artwork must be delivered ready to hang using the Hill Center cable-and-hook system. Details will be provided to selected artists. No size restrictions apply, as 14' ceilings in some gallery space can accommodate large pieces. Juror requests a short artist statement and a description of each piece. Submitted artwork must be from 2021-2023, not earlier. <u>All artwork must be available for sale.</u>

**PRIZES:** Three cash prizes and five Honorable Mention awards will be made. First place \$1000; Second Place \$750, Third Place \$500. Plus, Honorable Mention Certificates.

**ENTRIES:** Entries must be made online at <u>https://www.hillcenterdc.org/call-for-entries-hill-</u> <u>center-galleries-2024-regional-juried-exhibition/</u> or by visiting HillCenterDC.org/Galleries. Instructions are posted on the website.

**JUDGING:** The Exhibition will be juried by Amy Cavanaugh, Executive Director, Maryland Arts Place (MAP), Baltimore, MD – the anchor arts organization in Baltimore's Bromo Tower Arts and Entertainment District. MAP places emerging and mid-career artists in the spotlight with professionally-staged exhibitions and programs as well as community outreach. All artists will be notified of the Juror's decisions on/about Monday, December 4, 2023.

**DELIVERY/PICKUP:** Artwork selected for the exhibition must be delivered to Hill Center on Sunday, January 7, 2024 from 10:00am-3:00pm. Opening Reception with Juror, Wednesday January 24, 2024 6:30pm-8:30 pm.

**SALES:** Artists selected for the exhibition will be asked to sign the Hill Center Galleries Consignment Agreement. Hill Center Galleries shall sell artwork <u>at the sales price submitted in the</u> <u>on-line entry</u>, plus applicable DC sales tax, and remit proceeds to the artist, **retaining a 30% sales commission**. No price changes will be allowed after the call deadline.
